Exhibition proposals for the A.P.T Selected Programme are submitted to A.P.T's Gallery & Projects Committee for consideration at selection meetings throughout the year.

The next selection meeting will be on 7 April 2017. Exhibition proposal for A.P.T's Selected Exhibition Programme should be submitted as **TWO** PDF files and emailed/transferred to [aptlondon@btconnect.com](mailto:aptlondon@btconnect.com) three days before the meetings take place.

### 1-exhibition title\_proposal.pdf

- Clear outline of the exhibition proposal
- List of participating artists
- Details of the proposed education event(s)
- An indication as to how the exhibition will be funded

### 2-exhibition title\_images.pdf

- Participating artists' CVs and statements
- Images of the work
- Links to films / video / performance / sound
- List of work, describing visual material, title, date, size and medium of work
- Images of relevant press cuttings

General points about exhibiting at the A.P.T Gallery:

- Exhibitors will be expected to sign a contract and abide by the terms and conditions
- Gallery Charges : For exhibitions which run an education event the charges are: one week: £360, two weeks: £650, three weeks: £930, and four weeks: £1,240.
- The rental period is from 10am on the Tuesday of the first week to 4pm on the Monday of the last week, the published dates of the show are from a Thursday to a Sunday.
- The exhibitor will be required to organise one education event (talk / workshop etc.) during their show
- The exhibitor will be responsible for insurance of artwork
- The exhibitor will be responsible for invigilation during the core opening hours of the gallery which is Thursday to Sunday, 12 to 5pm
- The exhibitor will be responsible for printed material, mail-out and publicity
- The exhibitor will be required to make good the A.P.T Gallery by the end of the exhibition period (paint and filler is provided)
- The exhibitor will appreciate that A.P.T is a working studio environment for visual artists and must avoid unnecessary disruption in terms of noise or other disturbance.
- Occasionally the Gallery is used, during the run of an exhibition, for talks and discussions, training sessions, workshops and classes
- A.P.T requires that its name and/ or logo and /or charity number is used on all publicity material and mail-outs, and requests that proofs of all such material are provided before publication
